A few pieces of equipment need to be added yet, but as of April 21, 2012, the unit is ready to roll.



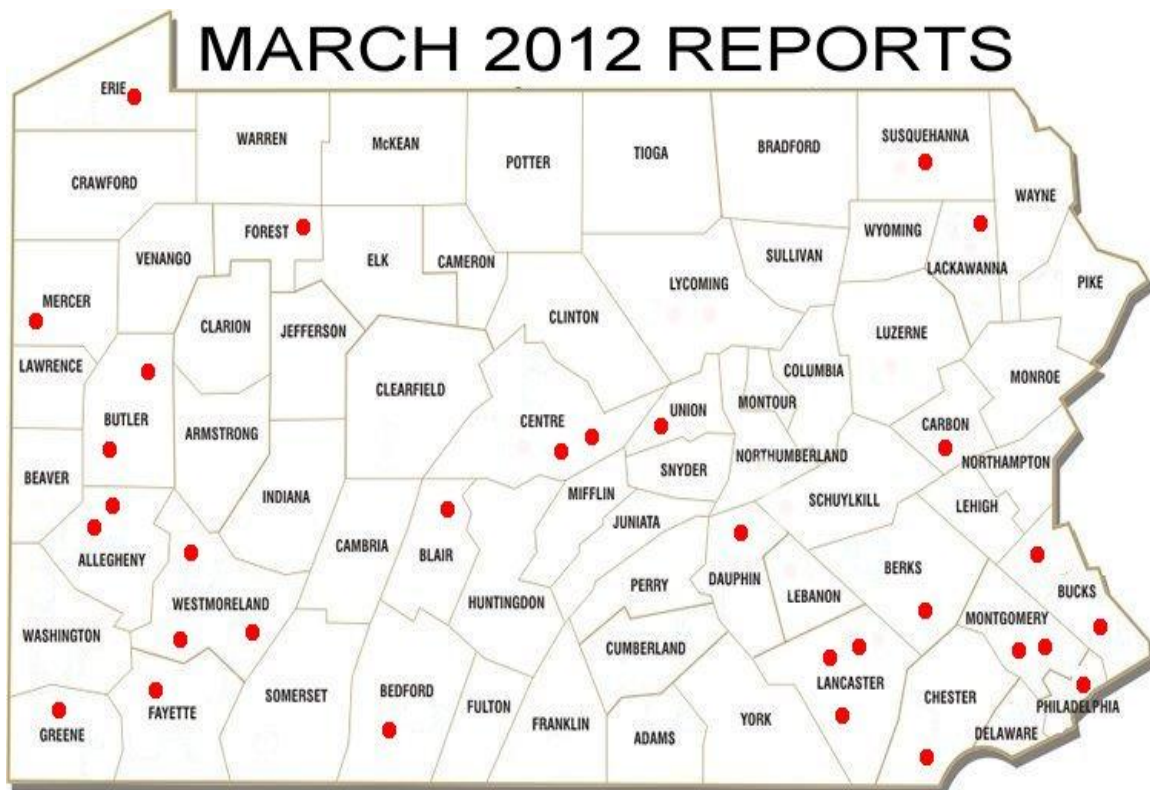

## INVESTIGATION TIPS

### **THE SIGHTING REPORT**

#### **a. Taking the Report**

#### **Procedure**

When taking the report, the investigator must:

Contact the witness by email or phone. Noting in the report the time and date of call or email. .

Accept and handle anonymous reports in the same manner as other reports, gather the same information from the anonymous witness as from any other witness, and encourage the witness to provide identifying information.

**Always try to obtain a face-to-face meeting.**

### **Methods Investigators Can Use When Interviewing A Witness.**

For all of these techniques, the investigator should consider the use of voice, including pitch, tone and pace.

**Questioning** is the primary technique for leading the witness through the information-giving process. Three types of questions are helpful:

**Open-ended questions** can be used for the purpose of stimulating the witness to talk. An example is “Can you please describe what you saw, step by step?” The witness



most likely will expand on answers and give the investigator the opportunity to probe into the subject under discussion.

**Closed-ended questions** restrict the witness response and may be useful to get a specific answer when the screener does not wish to stimulate further discussion. For example, questions such as, “Did you see the object clearly?” will most likely yield a “yes” or “no” response.

**Probing questions** should be used when a problem needs clarification at progressively deeper levels. An example of a probing question is, “You just said that you saw the object. Tell me, what color was it?” Simple directive probes such as “uh huh” and “please go on” are useful as encouragers, as are requests for specific information such as, “What was the objects shape?”

## b. The Report and Witness

**Repetition or rephrasing** of what a witness has said will help the investigator be sure the witness’s point is understood.

**Directness** is used when the witness doesn’t know what information is needed or is too emotional to know how to proceed. Give directions, telling the witness what information is needed, without being authoritarian or bureaucratic. For instance: “We can best help you if we know some specific information. I will ask you a series of questions. Please answer them as best you can.”

**Redirection** is used to interrupt if the information being given is unproductive or not relevant to the purpose of the report. For instance: “Now I need you to give me some specific information that will help us to follow through. Please

listen closely to my questions and give me clear, short answers to each one.”

**Supportiveness** is used to encourage the witness to continue to give the information needed, to support whatever role they play in the sighting in addition to making the report, and to enhance the witness’s view of your agency and system. For instance: “Thank you for your concern and for making this report.”

**Summarization** is used to briefly go over the important information that has been gathered to see if the witness has provided everything that is critical. Often, summarization will be combined with a final probe question. For instance: “Let’s see, you have given me information about your sighting, you’ve told me the color, size and shape of the object, it’s path of flight and it’s disappearing over that hill. Is there anything else that has you concerned about the sighting?”

**Dealing with Abusive Witness’s** is sometimes necessary. It is important for the investigator to stay calm and be clear that the conversation will not continue if the witness is abusive. For instance: “We will be better able to help if you give me the information without yelling and cursing. If you continue to use this language (tone of voice), I will end this conversation.”

**Regarding what will happen next.** It is important to let witness know the next steps, but not to give them information that is unknown.

### **Conclusion**

The investigator can conclude contact with the witness when the following has been accomplished: The necessary information has been obtained.

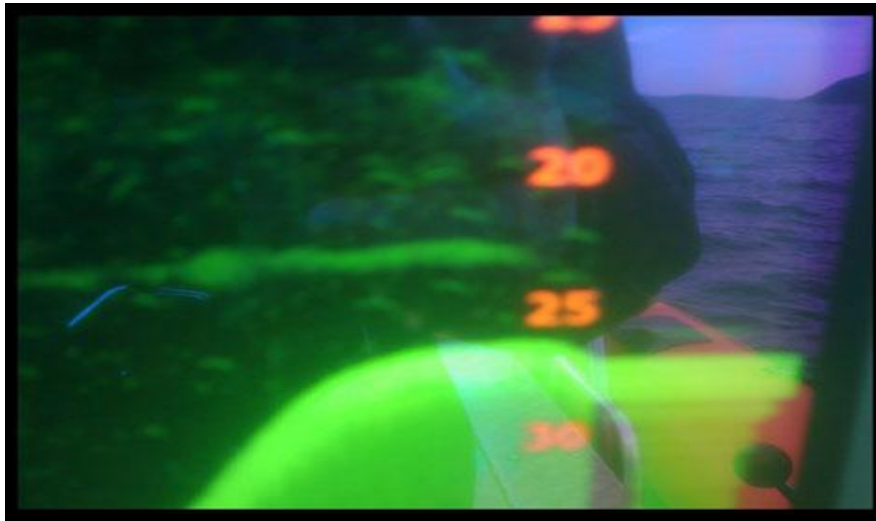
